

Introduction

1. These regulations define the terms and conditions of using the software published on <http://bazi-calculator.com/>.
2. By using this Website, you agree to terms and conditions listed below. Using paid services requires no separate agreement.
3. By using this Website, you agree the Administrator to processing your personal data that you provide, in purposes of providing services defined in these regulations.

Definitions

Website: <http://bazi-calculator.com> website.

User: a person using the Website.

Administrator: the owner of the Website, that is Wojciech Jach, residing in Olesnica 56-400, 3b/3 Kopernika street, Poland.

Using the Services

1. The Administrator provides services through the <http://bazi-calculator.com/> Website.
2. Using free services requires no registration.
3. Using paid services requires the User to register and pay license fee.
4. The list of paid services can be found at: <http://bazi-calculator.com/GoPremium.php>.
5. Registration in the Service is free for all users.
6. During registration the User sets this login, password and provides his actual email address.
7. The User can view and delete the data he added to the site.
8. The User is not allowed to share his account with third parties.
9. The license is assigned to one person, and it can be used on 5 devices (computer, laptop, phone etc).
10. The payment for paid services is made via PayPal, which regulations are available on <http://www.paypal.com>. On separate agreement, the payment can be made using different means.
11. The access to the paid part of the software is sold as a license for using the software. Selling the license to the User does not transfer the copyright (the Administrator of the Service remains the owner of the copyright). The user gets accesses to the software for a limited period of time, which is defined when buying the license on <http://bazi-calculator.com/GoPremium.php> page.

Technical requirements

1. To use the service, the User needs the software that meets the following requirements: web browser (the latest version) with enabled Cookies and Javascript. The minimum recommended screen resolution is 1280x720px.
2. The User must have an active e-mail account.
